








Daily Average Volume Traded (BY MARKET)



- The top 3 most liquid securities as measured by DAVT, were NCBFG, MASSY and GKC for the month of May 2025. NFM (330%), NCBFG (290%), GML (247%) and PLD (229%) monthly performance are notably above their respective 12-month moving average.
- RFHL took the lead with the largest number of transactions, recording 237 trades during the month of May 2025, followed by MASSY with 212 trades and FCGFH reported 173 trades for the same period.
- FCGFH, UCL, SBTT, PHL, MASSY and RFHL traded on all 21 trading days while WCO traded on 20 out of the 21 trading days during the month of May 2025.


Across the First-Tier, Mutual Fund and SME markets, the cumulative number of trades in May 2025 was 1,764, an increase of 157 trades or 9.77% compared to the trading activity in April 2025.

On a YOY basis, total trades recorded in May 2025 decreased by 166 or -8.60% compared to May 2024's trading activity.

On a YTD basis, total trades amounted to 8,178, representing a decrease of 272 trades or -3.22% over the equivalent YTD period in 2024.

On average, there were 84 daily trades recorded in May 2025 (April 2025: 85 trades), in comparison with the daily average of 92 trades recorded during May 2024.



NCBFG reported the highest market turnover ratio of 4.20% followed by UCL and NFM whose ratios stood at 2.23% and 1.52% respectively. Conversely, of all the securities traded, CINE1 reported the lowest market turnover ratio of 0.0002%.

NCBFG reported the highest market turnover ratio of 7.75% followed by UCL and NFM whose ratios stood at 5.05% and 2.69% respectively. Conversely, of all the securities traded, CINE1 reported the lowest market turnover ratio of 0.004%.
